### INFRASTRUCTURE, MAINTENANCE AND SERVICE

Chairperson Heck opened at 6:47 p.m. and said there are no drafts or pending legislation on the agenda.

Director Woodruff said Brian Cooper from Baker Tilly which is a financial and municipal advisor who has worked with the City on various funding mechanisms is here tonight. They will be talking tonight about a critical infrastructure need and walk through a plan to address a critically underfunded water and sewer lines. He does not think it comes as a surprise that there is a deficiency in the water distribution lines as well as the sanitary sewer lines.

Megan Meyer, Deputy Director of Public Affairs began her presentation to City Council on Water/Sewer Utility and Infrastructure Improvement Analysis.

### Current State of Water/Sewer Infrastructure

• Aging Infrastructure system overall- 50+ years of age in most segments

#### Underinvestment correlates to:

- Increased water main breaks
- Service interruptions
- Inflow/infiltration into sanitary sewer system
- Increased spending on repairs
- Recommendations
- Phase in water and sewer utility charge
  - July 1, 2022: Implement half of total combined surcharge of \$3.76 (half of total)
  - January 1, 2023: Implement total combined surcharge (\$7.52)

- Apply for Ohio EPA SRF for Water Main Projects
- Integrate 5-year CIP into annual budget conversations
- Revisit surcharge basis every two years as part of budget process

### Next Steps

- Early summer: Legislation introduced at City Council Subcommittee Meetings
- Legislation would go all three readings prior to consideration
- Public Affairs/Development Department to host a Virtual Town Hall during the consideration timeframe to help answer questions

# <u>Implementation Schedule (If adopted)</u>

- July 1, 2022: Phase 1 of surcharge implementation
- March 2022: Submit for Ohio EPA SRF Funding
- January 1, 2023: Phase 2 of surcharge implementation
